PLANNING DEPARTMENT: REQUEST TO SET A PUBLIC HEARING ON TUESDAY, JULY 9, 2024, FOR PLANNING CASE 23-08; TEXT AMENDMENT TO SECTIONS 12-21 AND 12-124 PRIVATE STORAGE BUILDINGS

At the March 19, 2024, Board of Commissioners meeting, staff presented a draft ordinance permitting storage buildings as a principal use for lots of three acres or greater in the Rural Agricultural (RA) and Rural Residential (RU) zoning districts. Staff believes the larger lot sizes will help to preserve the area for future residents and help to maintain a community's residential character. Staff also presented to the Board of Commissioners the planning board's recommendation of permitting the use of lots of one acre while suggesting standards addressing building size limitations for various lot sizes. The Board of Commissioners tabled the item and requested staff re-evaluate the proposed storage building amendments and seek options that may assist in preserving lots for future residences and prevent potential misuse of buildings.

<u>ACTION:</u> Commissioner Hardin made the motion, seconded by Commissioner Hutchins and unanimously approved by the Board to, *approve setting the public hearing as requested*.

SOCIAL SERVICES: NORTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES MEMORANDUM OF UNDERSTANDING

In 2017, the North Carolina General Assembly passed the Family/Child Accountability and Protection Act/Rylan's Law: Session Law 2017-41. The law requires the NC Department of Health and Human Services (NC DHHS) to enter into an annual written agreement with all counties for all social service programs, excluding medical assistance (NC Medicaid). The measures for the SFY 2024-2026 MOU and other supporting documents are included in Commissioners' packets. These are the only measures that will be evaluated and are subject to performance improvement actions. There is currently a pause in issuing corrective actions or development plans related to MOU performance. NCDHHS will work collaboratively with counties to meet measures and provide support. (a full copy of the MOU and supporting documents are on file in the Clerk's Office and Social Services Department).

<u>ACTION:</u> Commissioner Hardin made a motion, seconded by Commissioner Hutchins, and unanimously adopted by the Board to, authorize the signature of the Memorandum of Understanding by the County Manager and Social Services Director.

PUBLIC HEARINGS

PROJECT CRYSTAL

Chairman Gordon recognized Economic Development Director Courtney Ashley to present Project Crystal.

Project Crystal, a major manufacturing employer in Cleveland County, is considering expanding to the City of

Shelby. Logistics and the overall cost of doing business are big drivers for the expansion. This project will create

13 new jobs with an average wage of \$60,769 and a \$22,500,000 real property investment over three years. New tax revenue for the county and jobs would be created at substantially higher wages than the county average of \$48,000. The proposed grant incentive would be for three years at 20% of the \$0.5475 tax rate for three years for a total grant of \$51,465. In addition, the Cleveland County Economic Development Partnership recommends support for Project Crystal through the following:

- Cleveland County serves as the local government applicant for the Department of Commerce's Rural Division Building Reuse Grant
- The Rural Division has approved Project Crystal for up to \$100,000
- The grant requires a 5% match, which will be satisfied by grant management services provided by the County

Resolution Authorizing Economic Development Incentive for Project Crystal

WHEREAS, North Carolina General Statute 158-7.1 authorizes a county to undertake an economic development project by extending assistance to a company in order to cause the company to locate or expand its operations within the county; and

WHEREAS, the Board of Commissioners has held a public hearing to consider whether to offer a cash grant to Project Crystal (the "Company") to reimburse the Company a total sum not to exceed 20% of ad valorem tax revenues generated by expenditures the Company, an affiliate, or a lessor to the Company or an affiliate makes for real and personal property the Company or an affiliate purchases or leases and installs at, or relocates to, the Company's facility in the County which is subject to tax in the County over a period not to exceed three years; and

WHEREAS, the Project is estimated to have a taxable value of approximately \$22,500,000 and is estimated to create 13 new jobs in the County at an average salary of \$60,769; and

WHEREAS, this economic development project will stimulate, diversify, and stabilize the local economy, promote business in the County, and result in the creation of a substantial number of jobs in the County.

The Board of Commissioners of Cleveland County therefore resolves that:

- The county is authorized to reimburse the Company a total sum not to exceed 20% of ad valorem tax revenues generated by expenditures the Company, an affiliate, or a lessor to the Company or an affiliate makes for real and personal property the Company or an affiliate purchases or leases and installs at, or relocates to, the Company's facility in the County which is subject to tax in the County over a period not to exceed three years.
- The County Manager and County Attorney shall finalize an incentive agreement consistent with the terms of this resolution and substantially in the form attached hereto for execution by the Chairman of the Board of Commissioners on behalf of the Cleveland County Board of Commissioners.

Resolution in Support of the Project Crystal Building Reuse Grant

WHEREAS, it has been determined by the Board that <u>PROJECT CRYSTAL</u> intends to create over the next three (3) years, approximately thirteen (13) new, permanent full-time jobs with an annual average wage of Sixty Thousand Seven Hundred Sixty-Nine Dollars (\$60,769);

WHEREAS, <u>PROJECT CRYSTAL</u> anticipates creating approximately Twenty-Two Million Five Hundred Thousand Dollars (\$22,500,000) in net new investment, which will increase the population, taxable property base, and business prospects for the County;

WHEREAS, with the aforementioned expansions, Cleveland County qualifies for the North Carolina Department of Commerce, Rural Economic Development Division, Building Reuse Grant Program in which <u>PROJECT CRYSTAL</u> is eligible to receive a grant in an amount determined by the North Carolina Department of Commerce not to exceed Five Hundred Thousand Dollars (\$500,000) upon approval of a five percent (5%) grant match;

WHEREAS, the project in the grant application includes real and tangible personal property totaling Twenty-Two Million Five Hundred Thousand Dollars (\$22,500,000);

WHEREAS, it is in the public interest to provide assistance as authorized by North Carolina General Statute 158-7.1:

NOW, THEREFORE BE IT RESOLVED, for the reasons recited above that the Cleveland County Board of Commissioners hereby authorizes the County Manager to submit a Building Reuse Program grant application and provide a five percent (5%) grant match to qualify for the Project for the North Carolina Department of Commerce, Rural Economic Development Division, Building Reuse Grant Program.
