<u>RESOLUTION IN APPRECIATION OF</u> DR. IRVING WILLIAMS AND HIS WIFE MRS. GLORIA WILLIAMS

WHEREAS, Dr. Irving Williams, and his wife Mrs. Gloria Williams, are responsible for the creation of a nonprofit organization called Fresh Start.

WHEREAS, Fresh Start is an initiative by concerned citizens to address some of the developmental and learning difficulties facing the young residents of the community.

WHEREAS, Fresh Start was sparked by a burning desire, based on Christian principals. The Search Institute 40 Developmental Assets is utilized to identify and protect young people from a wide range of risky behavior, violence, alcohol use, and low self-esteem. <u>PLANNING DEPARTMENT: 6:00 P.M. PUBLIC HEARING ZONING MAP AMENDMENT - SILAS MASK</u> (Case 04-03) (400 Mt. Sinai Church Road, Shelby)

Bill McCarter, Planning Director, explained that Silas Mask has presented a petition to rezone approximately 0.77 acres located at 400 Mt. Sinai Church Road from Neighborhood Business (NB) to General Business (GB). Mr. McCarter stated, "You may remember this property was recently rezoned from Residential (R) to Neighborhood Business (NB) on January 6, 2004 and the Board of Adjustment issued a Conditional Use Permit to sell used cars on January 29, 2004."

Mr. McCarter reviewed the following background information regarding this case: <u>Existing Land Use:</u> A convenience store has been located on this property for many years, and this rezoning would allow a wide variety of commercial uses to develop on this property. Surrounding land uses are predominately residential.

Future Land Use: Expanding residential.

<u>Utilities:</u> CCSD has a 6" water line available along Mt. Sinai Church Road.

<u>Transportation:</u> These streets are not classified by NCDOT.

After reviewing the application and visiting the location, it is my opinion that the commercial zoning should stay as it is. The land use plan calls for expanded residential and all of the uses around the property in question are either vacant or residential. The property is more suited for Neighborhood Business than for General Business

Planning Board Recommendation: Deny

The Planning Board voted unanimously to deny this request, based on spot zoning, technical aspects of the request, and consistency with other decisions by the board.

<u>Spot zoning</u>: Rezoning a single property to a use that would allow this property owner certain privileges that the neighboring properties do not enjoy, may be found by the courts to be arbitrary and capricious, therefore invalidating the rezoning.

<u>Does Not Conform with the Land Use Plan:</u> This area is indicated as "Expanding Residential" on the 2005+ Projected Land Use Plan. Rezoning to a more intensive commercial use should be in an area designated as Expanding Commercial/Industrial.

<u>Surrounding Properties:</u> Adjoining properties are predominately residential.

<u>Non-Conforming Uses:</u> The existing convenience store is a permitted use in the Neighborhood Business (NB) zoning district.

<u>ACTION:</u> Ronnie Hawkins made the motion, seconded by Willie McIntosh, and unanimously adopted by the Board, to open the public hearing. (Notice of this hearing was accomplished in by legal advertisement published in the <u>Star</u> on April 21, 2004 and April 28, 2004.)

John McCullough, Chairman of the Planning Board, reviewed the Planning Boards recommendation and the reasoning behind their decision.

<u>ACTION:</u> Tom Bridges made the motion, seconded by Ronnie Hawkins, and unanimously adopted by the Board, to *close the public hearing*.

<u>ACTION:</u> Tom Bridges made the motion, seconded by Jerry Self, and unanimously adopted by the Board, to *deny the petition to rezone the property*.

<u>PLANNING DEPARTMENT: 6:00 P.M. PUBLIC HEARING - PAVING ASSESSMENT - RIDGEFIELD</u>

<u>ROAD</u>

<u>ACTION:</u> Ronnie Hawkins made the motion, seconded by Jerry Self, and unanimously adopted by the Board, to **open the public hearing**. (Notice of this public hearing was accomplished in accordance with NCGS 153A-194. A legal advertisement was published in the Star on April 21, 2004.)

Mr. McCarter reviewed that the North Carolina Department of Transportation has approved the addition of Ridgefield Road to the state highway system for maintenance. He advised the assessment process requires that two public hearings be held. At the first public hearing on August 6, 2002, the Assessment Resolution identified 19 lots to be assessed, being those lots show on Phase 3 of the Chatfield Farms subdivision recorded in Plat Book 18, Pages 50-51. The two corner lots were not included in this proposal. The resolution was adopted and the paving bid was awarded to Kennedy Concrete & Utilities.

Mr. McCarter said, "The purpose of the second public hearing is to confirm the amount to be assessed against each lot. The Board may cancel, increase, or reduce the assessment on each property as may be needed to comply with the basis of assessment which is an equal rate per lot (NCGS 153A-

195)." He reviewed the final costs as itemized below:

FR Ledford & Associates - Design plan and profile: \$1,238.00 FR Ledford & Associates - Right of way plat: \$180.00 David Ledford - Erosion Control Plan: \$738.00 NCDEHNR - Erosion Control Permit: \$120.00 Kennedy Concrete & Utilities: \$59,942.92 Cleveland County - Administrative Fee: \$2,340.00

Total Costs: \$71,498.99

Cost per lot (19 lots): \$3,763.10

Linda Tesseneer Hallsey told Commissioners she was of the impression after the last public hearing that the two corner lots would also be assessed. She felt that property had also been improved by the paving and therefore those property owners should also share in the cost of paving.

Roger Hallsey supported his wife's statements, saying he felt the corner lots benefitted enough from the paving to substantiate their being included in the assessment.

There was discussion as to what had transpired at the previous public hearing and what was or was not to be included in the assessment roll, as well as the need to be consistent when assessing this type lot. It was decided to delay a decision until Mr. McCarter could research the minutes of the previous public hearing.

<u>ACTION:</u> Willie McIntosh made the motion, seconded by Ronnie Hawkins, and unanimously adopted by the Board, to continue this public hearing until May 18, 2004 at 6:00 p.m. <u>PLANNING DEPARTMENT: ZONING MAP AMENDMENT - John McBrayer (Case 04-06) (Along US-74) (Request for public hearing on June 1, 2004 at 6:00 p.m.)</u>

<u>ACTION:</u> Willie McIntosh made the motion, seconded by Jerry Self, and unanimously adopted by the Board, to schedule the public hearing as requested.

<u>PLANNING DEPARTMENT: CODE AMENDMENT - Edmond G. Howard, Jr. (Request for public hearing on June 1, 2004 at 6:00 p.m.)</u>

There was discussion as to the appropriateness of a duplex being built, even as a conditional use, in a Restricted Residential *(RR)* zoning district. It was noted that these type structures are usually used as rental properties and do not fit the character established by this type zoning district.

<u>ACTION:</u> Jerry Self made the motion, seconded by Ronnie Hawkins, and unanimously adopted by the Board, *to deny the petition*.

<u>ACTION:</u> Jerry Self made the motion, seconded by Willie McIntosh, and unanimously adopted by the Board, to *refer all text amendments to the Planning/Zoning/Development Ordinance* to the Planning Board for their review and recommendation prior to coming to the Board of Commissioners for consideration, excluding video gaming amendments (reference April 20, 2004 minutes).

MISCELLANEOUS BUSINESS

KINGS MOUNTAIN"THANKS FOR THE MEMORIES"

Vice-Chairman Hawkins stated, "I just wanted to acknowledge the work that you *(Chairwoman Accor)* did last night at the school in Kings Mountain . . . thanks for the memories, since the Kings Mountain Schools are no longer going to be the Kings Mountain District Schools in a few days, and Mary put on a program last night, and we honored all the people and services, and it was a great program and a good job."
