## **CLEVELAND COUNTY BOARD OF COMMISSIONERS**

#### June 7, 2005

The Cleveland County Board of Commissioners met in a regular session on this date, at the

hour of 6:00 p.m., in the Commission Chamber of the Cleveland County Administrative Offices.

#### CALL TO ORDER

Chairman Hawkins called the meeting to order, led the audience in the "Pledge of Allegiance" to

the flag of the United States of America and provided the invocation for the meeting.

## SPECIAL RECOGNITION: CLEVELAND COUNTY URBAN SEARCH AND RESCUE,

#### <u>SWIFTWATER DIVISION – NATIONAL AWARD</u>

Chief Roland Hamrick, Shelby Fire Department, advised the Swiftwater Rescue Team was

nominated for the Higgins & Langley Memorial Award for Outstanding Achievement in the Field of

Swiftwater Rescue by Governor Mike Easley and is the highest international award in this field.

Bryan Beatty, secretary of the Department of Crime Control & Public Safety, was quoted as

saying, "This award recognizes the preparedness, teamwork, and dedication of our swiftwater rescue

teams under extreme conditions during the seven storms in 2004." Cleveland County's team took part in

the rescue of five people stranded by rising water along a remote stretch of river below the Cedar Cliff

Dam in Jackson County in September, 2004.

p.m. to consider the petition submitted by Alltel Communications, Inc. to amend the zoning map for

property located at 2738 South Post Road from Residential Corridor Protection (RCP) to

Neighborhood Business (NB).

### <u>CLEVELAND COUNTY BUDGET: FISCAL YEAR 2005-2006 – PUBLIC HEARING</u>

David C. Dear, County Manager, advised that it is the County Manager's responsibility to present

each year to the Board of Commissioners a balanced budget. He briefly reviewed the budget process,

stating that in February during their work session, Commissioners "gave guidance to the County" Manager that there was to be no tax increase and no reduction in services, if possible." During another work session, Commissioners heard department heads present their budget requests and "reiterated the no tax rate increase theme." Other work sessions were also held, including a joint meeting with the Shelby City Council members to negotiate an agreement to secure the long-term viability of the Cleveland Memorial Library, as it will now become a county department.

Mr. Dear noted that a full-page color advertisement was published in all the local print medial seeking public input to the budget process with the hope of raising public awareness.

Mr. Dear stated, "I want to thank the County Commissioners for their unwavering guidance and support through the budget process, and I want to thank all of our department heads for their spirit of cooperation and their willingness to compromise on some tough issues. This budget was truly a team effort and I appreciate everyone who helped with the process."

Financial hardships were listed by Mr. Dear as:

- \$414,000 increase in public assistance costs (Medicaid) •
- \$100,000 plus increase in fuel cost for county vehicles
- Rising utility rates (water, sewer, gas and electric) •
- Increasing rates for property and liability insurance •

Mr. Dear stated, "After taking into consideration all the hardships

and added expenses previously discussed, the Cleveland County Board of Commissioners has fashioned a budget that includes an increase of \$1,242,625 (or 2.43%) in general fund expenditures. This is a very conservative budget and fits within the parameters of no tax rate increase and no reductions in services to the public."

He reviewed other budget highlights as follows, stating the budget has provided for the following items:

- A children's' literacy initiative in conjunction with Cleveland County Schools. •
- A volunteer appreciation event for the fall of 2005.
- An anti-litter campaign in conjunction with local law enforcement.
- A limited overtime program for the Sheriff's Department.
- A \$30,000 increase in funds for economic development. •
- Upgrades to the 911 telephone answering equipment. •
- Replacements for eight patrol cars, one ambulance and one quick response vehicle. •
- Two new full-time clerical positions one in the Sheriff's Department and one at public health. We also added a 50% shared position at Social Services to determine Medicaid eligibility.
- 2% cost of living allowance for all county employees.
- 6% increase in health insurance costs for employees. •
- Increased mileage reimbursements for vehicles usage from 30 cents to 32 cents per mile due to the soaring gas prices.
- Added approximately 12,000 square feet of space for the Health Department to alleviate over crowding, which added expenses for utilities and maintenance.
- Additional funding for books and materials at the Cleveland County Memorial Library. •

Chairman Hawkins declared the public hearing open at 6:35

p.m. (Public notice of this hearing was accomplished in accordance with NCGS 159-11 and NCGS 159-12, with legal advertisements published in <u>The Star</u> on May 13, 2005 and May 27, 2005. The proposed budget has been available for public inspection in the office of the County Clerk since May 25, 2005.)

*M. A. Andrews* spoke regarding the City of Shelby's decision to use "rolling carts" for trash pick up, stating he was against this method of trash collection and that city residents are also county residents.

*John Cline*, Cleveland County Sanitary District Chairman, thanked Commissioners for their budget explanation ad in the newspaper, stating it had "enlightened" him greatly about the budget.

Hearing no further comments, Chairman Hawkins closed the public hearing at 6:40 p.m.

Commissioners commended Mr. Dear for a "job well done" and stated this is a budget of which citizens should be proud. Commissioners also thanked department heads and staff for their cooperation and support during this budget process.

<u>ACTION:</u> Mary Accor made the motion, seconded by Willie McIntosh, and unanimously adopted by the Board, *to adopt the budget for fiscal year 2005-2006 as presented by the County Manager* (*a copy of the Manager's Budget Message and a copy of the Budget Ordinance are found on Pages*

#### MISCELLANEOUS BUSINESS

Commissioner Accor invited Commissioners to attend the upcoming annual Distinguished Image Awards on Friday at 6:00 p.m. at Malcolm Brown Auditorium. She stated this is a part of the Closing the Gap initiative and 42 students will be recognized.

Vice-Chairman Self reported he attended the NCDOT public hearing to "plead our case for the 74 bypass." He said, "It looks like under the present plan, it will be 2008 before they start acquiring rightof-ways and it will be fiscal year 2011 before they start construction."

Vice-Chairman Self also stated that today he and his wife, Carolyn Wray Self, are celebrating their 41<sup>st</sup> wedding anniversary, which drew a round of applause!

Chairman Hawkins reminded Commissioners of an upcoming ribbon cutting on Sunday at 4:00 p.m. at the Kings Mountain Oriental Avenue groundbreaking for retirement apartments.

Chairman Hawkins stated, "Also, Friday night, the Republicans had what is called a Reagan Day .

. . and Ruth Wilson has had an award named after her because of her spirit, so we have the Spirit of Ruth Wilson Award now, with the first recipient being Ruth Wilson." Commissioners congratulated Mrs. Wilson, who was present.

Mr. Dear reminded Commissioners he would be in Raleigh tomorrow, "with a delegation from Cleveland County Chamber pleading our case for Medicaid relief in the legislature and would like to

encourage you to call our legislators tomorrow regarding Medicaid relief."

# <u>ADJOURN</u>

There being no further business to come before the Board at this time, Mary Accor made the motion, seconded by Johnny Hutchins, and unanimously adopted by the Board, to adjourn the meeting (*at 6:45 p.m.*). The next regular meeting of the Commission is scheduled for *Tuesday, June 21, 2005 at 6:00 p.m.* in this Commission Chamber.
