<u>PROCLAMATION HONORING OCTOBER 2014 BREAST CANCER</u> <u>AWARENESS MONTH</u>

Chairman Falls asked the clerk to the read the following proclamation:

Number 09-2014

Breast Cancer Awareness Month

WHEREAS, last year, more than 230,000 women and 2,000 men were diagnosed with breast cancer in America, as well as 102 cases in Cleveland County; and

WHEREAS, the heartache and the pain of this disease has already touched too many of our mothers, fathers, daughters, sisters and other family members; and

WHEREAS, when breast cancer is caught early, treatments work best and survival rates increase; and

WHEREAS, all women and men should be familiar with risk factors and symptoms of this disease and should take every effort to be screened annually; and

WHEREAS, this nation has invested billions of dollars into critical research to better understand the causes of breast cancer, develop treatments and create better diagnostic tools; and

WHEREAS, those that have been lost to this disease as well as those who have survived all deserve our remembrance and honor;

NOW, THEREFORE, the Cleveland County Board of Commissioners, hereby proclaims October 2014, as "Cleveland County Breast Cancer Awareness Month" and encourages all citizens to join them in recognizing the impact that breast cancer has on the citizens of Cleveland County and how we can all move forward to combat this disease together.

Chairman Falls then recognized Commissioner Hutchins, who said 25% of women will develop breast cancer. He then asked anyone who has had

family touched by breast cancer to stand, with more than half of the room standing. Commissioner Hutchins called on Rita Wortman, Clinical Health Educator at Cleveland Regional Medical Center, to come forward. Ms. Wortman spoke about the hospital's commitment to working on the plague of breast cancer and about the local work the hospital is doing to help alleviate the bills that local residents accrue during treatment.

Commissioner Hutchins then recognized Julie Pearson, a specialist with Relay for Life in Charlotte, and she spoke about their program and their commitment to ending breast cancer through research. The commissioners then took a picture with Ms. Wortman, Ms. Pearson, Allison Mauney and Pat Spangler (staff that had survived breast cancer) and local Shelby and Kings Mountain Relay for Life representatives.

REGULAR AGENDA

PRESENTATION BY NTE: Chairman Falls called Mike Green of NTE to come to the podium. Mr. Green spoke on NTE being the cleanest power plant in North and South Carolina, and possibly in the United States. Mr. Green said the new NTE generator is uses natural gas and gets turbine power generation through combustion and steam at 475 megawatts. The project will begin in April 2015 and will create 300 construction jobs and use 290 acres. The company is hoping for a 40 year life with the plant and is looking

forward to public/private partnerships and look forward to being a long term corporate citizen for Cleveland County. Duke is finalizing their interconnections so that NTE can tap into their lines. NTE is excited about being in Cleveland County because of good support and good community size. NTE hopes to utilize the community college and create partnerships and training opportunities for new workers in Cleveland County. Chairman Falls then added that he appreciated the fact that NTE vowed to use local contractors for their project. The commissioners then took a picture with Mr. Green.

COMMISSIONER REPORTS

Commissioner Allen: Commissioner Allen said she had nothing.

Commissioner Hutchins: Commissioner Hutchins spoke on the 16 firms that were present for the gun range pre-bid meeting. He then mentioned in the MPO meeting that the state had changed their scoring system for road projects which could pit local projects against each other, possibly stalling certain projects.

Commissioner Holbrook: Commissioner Holbrook thanked Commissioner Hutchins for his work with the MPO and keeping the Commission up to speed.

Commissioner Falls: Chairman Falls said he and Commissioner Holbrook shut the fair down campaigning. He said he enjoyed meeting and speaking with many people from the community.

<u>ADJOURN</u> Commissioner Hutchins made the motion to adjourn the meeting, it was seconded by Commissioner Allen and unanimously approved. The next scheduled meeting will be Tuesday, October 21st at 6:00 p.m. in the Commissioner's Chambers.
