# Cleveland County Board of Commissioners December 16<sup>th</sup>, 2014:

The Cleveland County Board of Commissioners met in a regular session on Tuesday, December 16<sup>th</sup>, 2014 at 6:00 p.m. in the Commission Chamber of the Cleveland County Administrative Office.

### **CALL TO ORDER:**

Chairman Falls called the meeting to order. Community Services Director Kerri Melton then led the audience in the Pledge of Allegiance and provided the invocation for the meeting.

### **AGENDA ADOPTION**

<u>ACTION:</u> Chairman Falls opened the meeting requesting that item 18, a closed session to discuss attorney-client privilege. Commissioner Hutchins made

the motion, seconded by Commissioner Allen, and unanimously adopted by the Board, to adopt the agenda with the addition of item 18.

#### **CITIZEN RECOGNITION**

Robert Williams: 814 E. Stagecoach Trail, Fallston, NC. Mr. Williams wanted to discuss the cost of the shooting range. He said he looked through the agenda packet and saw the low bid for the range was \$2,206,425 and \$425,613 for the restrooms/concessions and it all adds up to \$2,631,638. He read that there was going to be a \$500,000 county contribution plus the fact that the county probably paid over \$1,000,000 for the land originally so to add that up puts the total over \$3,000,000. Do we need a \$3.6 million shooting range?

The Wildlife and Land Commission is giving 1 million so that means the county is going to have to come up with \$1.6 million. This is a lot more than was originally thought. Maybe the county needs to reconsider the project.

PUBLIC SHOOTING RANGE: County Manager Richardson outlined an addendum to the Memorandum of Agreement with the NC Wildlife Commission. The MOA outlines that the Wildlife Commission will outline all costs for the base bid for the shooting range (\$1,668,663.00). They are asking Cleveland County to cover the costs of the public buildings (2<sup>nd</sup> construction bid, Item J) in the amount of \$424,613.00. The county is also responsible for alternates 2-6 (\$536,000.00) and the county will be responsible for day to day operations and to appoint an advisory board. Later in this meeting the Commissioners will appoint a board member to that shooting range.

**PUBLIC SHOOTING RANGE:** Bid construction for phase 1 and the recommendation is to accept Eaglewood's base bid for \$2,206.425.

**PUBLIC SHOOTING RANGE:** Bid construction for public buildings, recommendation is TK Strickland's construction bid is \$424,613.00. As a reminder, Commissioners were reminded that this sits on 82 acres of buffer area of landfill space and the site has been explored by engineers and is ready for construction.

#### **PUBLIC HEARING**

# CLOSEOUT OF THE 2012 COMMUNITY DEVELOPMENT BLOCK GRANT-FOOTHILLS COMMERCE CENTER SHELL 2 BUILDING:

Chairman Falls called up Paula Kempton, Isothermal Planning and Development Commission. Ms. Kempton said the county, in 2012, received \$1,000,000 from the NC Commerce Department for the construction of the shell building. The county invested \$25,000.00, as was required by the grant agreement. The building has 100,000 square feet with the ability to expand to 200,000 square feet and is now complete. Commissioners were given the details of the agreement in their packets.

Chairman Falls opened up the public comment at 6:38 p.m. and, hearing no comment, closed at 6:39 p.m. Chairman Falls stated that this was a win/win for the county. Without this building it is a handicap to getting businesses

interested in Cleveland County. This building puts us ahead. Chairman Falls then asked for a motion and the motion was made by Commissioner Hutchins and was seconded by Commissioner Holbrook to close out the Community Development Block Grant. The motion passed unanimously.

#### **REGULAR AGENDA**

LATE APPLICATIONS FOR EXEMPTION: Chairman Falls called Chris Green, Tax Administrator, to the podium. Mr. Green said being at the end of 2014, here is a list of applicants (DAV, Elderly and Disabled), Religions and Present Use Value. Mr. Green said all have been reviewed and meet the criteria with the exception of being untimely. It is up to the board's discretion to approve them or not. Fiscal impact will be under \$5,000.00. Chairman Falls asked for discussion and seeing none, Commissioner Hutchins made a motion to approve the exemptions, seconded by Commissioner Allen and unanimously approved.

**RESOLUTION BETWEEN CLEVELAND COUNTY AND THE CITY OF SHELBY FOR BUILDING INSPECTIONS:** County Manager

Richardson said the county had the unique opportunity to help the City of

Shelby by providing Building Inspections Services on a temporary basis.

There has been a loss of personnel in that department and the city cannot continue to do building inspections within the city's jurisdiction. The

county did the same thing for Kings Mountain for one month during the summer. County Manager Richardson said he spoke with Paul Ezell, Cleveland County Building Inspections Director, and that Mr. Ezell believed they had the capability to expand the workload through the winter months. The contract will be in effect through June 30<sup>th</sup> but Mr. Richardson believes that it will not take that long for the city to be able to take back over the building inspections. The city of Shelby will assume all costs associated with this move. Mr. Richardson asked the board that they allow him to work out the operational details with Rick Howell, City of Shelby Manager.

A JOINT RESOLUTION BETWEEN THE CITY OF SHELBY AND CLEVELAND COUNTY CONCERNING BUILDING INSPECTORS

WHEREAS, the City of Shelby and Cleveland County Government have maintained a cooperative relationships in a number of a areas over the past several years; and, WHEREAS, the City Manager has made the Mayor and City Council aware of some unanticipated staffing shortages in the Building Inspector Level III position within the Planning and Development Services Department that may result in delays in service delivery specific to building plan review and inspections; and,

WHEREAS, due to the unanticipated staffing shortage in the Building Inspector Level III and the temporary nature of the vacancies in this position the City Manager is requesting authorization to enter into an agreement with Cleveland County Government; and WHEREAS, in order to address the staffing issue and provide timely plan review and building inspections to development community the City of Shelby may need to obtain the services of one or more building inspectors employed by Cleveland County; and,

**WHEREAS,** North Carolina General Statute 160A-413 states in part as follows: "A City Council may designate an inspector from any other city or county to serve as a member of its Inspection Department with the approval of the governing body of the other city or county."; and,

**WHEREAS**, North Carolina General Statute 160A-360(g) provides that the agreement set forth in North Carolina General Statute 160A-413 "be evidenced by a formally adopted resolution"; and,

WHEREAS, the City Council of The City of Shelby desires to authorize the City Manager to designate one or more inspectors from Cleveland County to serve as a member of its Inspection Department for a period beginning on Monday, December 22, 2014, and ending on Tuesday, June 30, 2015; and,

**WHEREAS**, the Board of Commissioners of Cleveland County desires to approve said designation for the time stated.

#### **NOW, THEREFORE**, be it resolved as follows:

1. The City Council of the City of Shelby hereby authorizes the City Manager to designate one or more inspectors from Cleveland County to serve as a member of the

City's Inspection Department for the stated period beginning on Monday, December 22, 2014, and ending on Tuesday, June 30, 2015.

- 2. The Board of Commissioners of Cleveland County hereby approves said designation of one or more of the County's inspectors to serve as a member of the City's Inspection Department for the time indicated above.
- 3. That Cleveland County shall not incur any additional costs and shall be compensated accordingly for the services rendered to the City during this period of time. This Resolution shall become effective upon its adoption and approval by both the City Council of the City of Shelby and the Board of Commissioners of Cleveland County.
