In previous years, the Secondary Road program offered two types of funding- rural paving and subdivision paving. To date, all subdivision roads have been paved leaving only rural paving.

Beginning July 1, 2007, \$68 million of the Highway Fund will be used toward paved road improvements. Improvements will include eliminating hazards and widening narrow roads.

Commissioner Hawkins thanked Gary Spangler and the NCDOT for all that they do to help with economic development in Cleveland County.
