HEALTH DEPARTMENT: WRITE-OFF OF ACCOUNTS RECEIVABLE

NC PUBLIC EMPLOYEE DEFERRED COMPENSATION PLAN

Cleveland County Human Resources has presented a recommendation to offer an additional deferred compensation plan to County employees.

NC Public Employee Deferred Compensation Plan

WHEREAS, the members of the Cleveland County Board of Commissioners wishes to provide a qualified defined contribution plan to the employees of Cleveland County; and

WHEREAS, the State of North Carolina has established the North Carolina Public Employee Deferred Compensation Plan, a qualified governmental Deferred Compensation Plan under the Internal Revenue Code 457B for public employees of North Carolina;

NOW THEREFORE, BE IT RESOLVED THAT, the Cleveland County Board of Commissioners hereby adopts the North Carolina Public Employee Deferred Compensation Plan also known as "NC Deferred Comp" under the terms of the Plan Document and the Third Party Administrator Agreement. All employees shall become eligible to defer compensation immediately.

WHEREAS, this year's theme, "Emerging Business and Community Leaders: A Blueprint for Success" represents this nation's immense human and leadership capital within our free enterprise system to help foster strategic alliances and economic viability through continuous improvements, collaboration, innovation, competitiveness, and workforce preparedness in an ever changing global society; and

WHEREAS, the 16th Annual Awards Luncheon will bring together small business owners, local business and government officials, and community stakeholders to honor and commemorate the accomplishments of small business owners, local citizens and community partners who give of their time to make a difference in our local community; and

WHEREAS, the Cleveland County Business Development Center in collaboration with Cleveland Community College, Shelby High School, Infinity Media, The Shelby Star, and other local sponsors have teamed up to promote greater community awareness and participation in youth mentoring and talent development programs, women in business forums, education outreach, volunteerism, and access to opportunities and information that improve the overall quality of life in Cleveland County;

Commissioner Hawkins recognized Robert Miller, a member of the Cleveland County Board of Health for his work on the Health Board. Commissioner Hawkins described him as "an integral part of the board."

PUBLIC HEARINGS

ECONOMIC DEVELOPMENT INCENTIVE AGREEMENT: CASE FARMS

Ken Mooney, Manager of Existing Industry, presented the Case Farms, LLC incentive agreement to Commissioners for review. He highlighted the incentive agreement as follows:

- New jobs and investment are to be created at 1524 Airport Road, Shelby.
- Project will create approximately \$6.74 Million in new taxable investment over two years.
- Grant term- 5 years.
- Project will create ten (10), new, full-time jobs.
- The grant award will be the appraised value of the net new taxable investment of the project of each of the five years multiplied by .0057 (tax rate) multiplied by 40%.
- The value of the equipment will be determined by the Tax Assessor.
- All applicable taxes must be paid in full.
- Grantee is required to provide any information to the county in order to be in compliance with the grant agreement.

Chairman Hutchins opened the public hearing and asked anyone wishing to speak for or against the proposed incentive agreement to come forward.

<u>Michael Chrisawn, Cleveland Chamber President,</u> called this project "another opportunity for jobs." Case Farms is an existing industry in Cleveland County. Again, he noted, he believes existing industry will lead the way out of the recession. "Case Farms is a small business....We believe in our small businesses."

Hearing no other comments, Chairman Hutchins closed the public hearing.

<u>ACTION:</u> Ronnie Hawkins made the motion, seconded by Jason Falls and unanimously adopted by the board, to approve the incentive agreement as presented (copy of agreement found on Pages ______ of Minute Book _____).

REGULAR AGENDA

CITY OF SHELBY- NATURAL GAS PUBLIC AWARENESS MEETING

Federal law requires public utility providers to hold public awareness meetings to keep Government Officials and citizens informed of natural gas safety issues. Ronnie Davis, City of Shelby Utility Compliance Coordinator spoke to Commissioners about the goals of the City of Shelby Gas Department including providing safe, reliable gas service to customers and ensuring the safety of people living and/or working near gas pipelines. Mr. Davis educated the public on pipeline markers, farm tap regulator stations, meter set and regulator stations. He talked about the importance of calling 811 before you dig and made note that the number one cause of gas leaks is third-party damage accidents. Lastly, he informed the public on how to recognize a gas leak (see, hear and smell) and stressed that you must call 911 immediately if you suspect a gas leak.

<u>ACTION:</u> Jason Falls made the motion, seconded by Eddie Holbrook, and unanimously adopted by the Board, to conduct a closed session to discuss two issues;

-To consult with the county attorney in order to preserve the attorney-client privilege, as allowed under North Carolina General Statute 143-318.11(a)(3)

-To discuss a personnel matter, as allowed under North Carolina General Statute 143-318.11(a)(6).

Chairman Hutchins reconvened the meeting in open session.

Regarding the consultation with the county attorney, Commissioners gave instruction to the County Attorney on the legal matter. No action was taken.

Regarding the personnel matter:

<u>ACTION:</u> Ronnie Hawkins made the motion, seconded by Jason Falls, and unanimously adopted by the Board, to appoint Eddie Bailes as Interim County Manager effective January 1, 2012.

Commissioner Hawkins:

Commissioner Hawkins attended an Airport Commission meeting. The pouring of a new helicopter pad has been completed as well as renovations to the ramp facilities. He suggested possibly

hosting a County Commissioners in the conference room at the Airport.

Commissioner Hawkins provided lunch for Animal Control and the Humane Society. He is very

pleased with the cooperation that has taken place between these two groups and is looking forward to

another adoption event.

Commissioner Holbrook:

Last Friday, Commissioners dedicated the Foothills Commerce Center. Dan Gerlach of the

Golden Leaf Foundation attended and following, he visited the LeGrand Center. Mr. Gerlach

commented, "It is always good to come to Cleveland County because this county moves."

Commissioner Falls:

Commissioner Falls has been working with Cooperative Extension, Uptown Shelby Association

and Travel and Tourism to promote a "buy local" program.
