PUBLIC HEARING

Economic Development Incentive Agreement on Project Rich: Chairman

Falls called up Stuart Hair, associate director of Cleveland County Economic Development Partnership. Mr. Hair said his focus at the Partnership is aiding existing businesses, so he was bringing forward a new economic incentive agreement called Project Rich. The company employs 44 people and is looking to create \$10,000,000 in new taxable investment and 10 new jobs within the next three years. Commissioners were given the draft agreement in the agenda packet.

Chairman Falls opened up the public comment at 6:51 p.m. and, hearing no comment, closed at 6:52 p.m. Chairman Falls asked for a motion and the motion was made by Commissioner Hawkins and was seconded by

Commissioner Holbrook to approve Project Rich as presented. The motion passed unanimously.

REGULAR AGENDA

GATEWAY TRAIL PHASE 5 CONSTRUCTION GRANT: Chairman

Falls called Bill McCarter, Planning Director to the podium. Mr. McCarter recognized Shirley Brutko and Bill McMurray who were Gateway Trail Board members. Mr. McCarter said the grant is there to add 3 more miles to the current 5.2 miles of the Gateway Trail. Phase 5 is going to take the park all the way to I-85. Mr. McCarter emphasized that there are 3 phases to the project; engineering, right of way and construction. The county has the option to stop at any phase of the project if the county does not see fit to continue or there are unforeseen costs the county does not wish to assume. A few cons from the project are extended oversight due to it being a federal grant. The county will have oversight of the project and Mr. McCarter will personally oversee the project from the county's perspective. Chairman Falls asked the question if the county was fronting the money for the project and Mr. McCarter said yes. The grant is set up as a reimbursement grant, which is customary with this type of grant. Commissioner Hutchins made a motion to approve the grant as presented

and Commissioner Hawkins seconded. It passed unanimously.
