Proclamation declaring April 6-10 Public Health Week: Chairman Falls introduced Dorothea Wyant, Health Director, and invited her to the podium. The clerk then read the proclamation. #### A Proclamation in Support of National Public Health Week

Whereas the week of April 6–12, 2015 is National Public Health Week and the theme is "Healthiest Nation 2030", with the goal of working to become the healthiest nation in one generation; and

Whereas since 1995, the American Public Health Association, through its sponsorship of National Public Health Week, has educated the public, policymakers and public health professionals about issues important to improving the public's health; and

Whereas the Cleveland County Health Department's mission is to assure, enhance and protect the health of Cleveland County citizens through education and prevention; and

Whereas preventing diseases before they start is critical to helping people live longer, healthier lives while managing health-related costs; and

Whereas public health action together with scientific and technologic advances have played a major role in reducing and in some cases eliminating the spread of infectious disease and in establishing today's disease surveillance and control systems; and

Whereas preventable chronic diseases such as heart disease, cancer and diabetes are responsible for millions of premature deaths each year; and

TRAVEL AND TOURISM UPDATE: Chairman Falls introduced Jackie Newton, Travel and Tourism Director, to the podium. Mrs. Newton said there is a buzz in Cleveland County, hotel occupancy is up by 4%. 24 travel writers came to Cleveland County, Garden and Gun Magazine named Red Bridges the best barbecue restaurant in America. This year a new hotel will be built, and the new gun range will bring new competitions and new visitors to Cleveland County. 91.95 million in 2013 in economic impact from travel and tourism events, which is a savings of \$71 in tax revenue per person.

#### A Proclamation Declaring August 13, 2015 Jim Horn Day

Whereas Jim Hom has been a constant figurehead in the Shelby sports community where he is a member of the Cleveland County Sports Hall of Fame, and has been a longtime member of the Hall of Fame committee; and

Whereas Jim Hom played football, basketball and baseball at Shelby High School and after graduating high school went on to play baseball at Wake Forest, where he played on the 1955 NCAA championship baseball team; and

Whereas Jim Horn returned home and served as a defensive football coach at his high school alma mater for over 20 years and was instrumental in bringing the Fellowship of Christian Athletes to the Shelby community; and

Whereas Mr. Horn was a community leader, having served on many boards in Cleveland County as well as a member of the North Carolina House of Representatives from 1998-2000; and

Whereas Mr. Horn cared deeply about his faith, tirelessly serving First Baptist Church of Shelby, teaching Sunday School and serving as a Deacon and Deacon Board Chair, and

Whereas one of Mr. Horn's greatest pleasures was serving as co-chair of the American Legion World Series, where he was instrumental in helping solidify Shelby as the permanent home of the American Legion World Series, even being inducted into the American Legion Baseball Hall of Fame.

NOW, THEREFORE, the Cleveland County Board of Commissioners do hereby proclaim August 13, 2015, the first day of the American Legion World Series, to be Jim Horn Day in Cleveland County. The Commissioners call upon the citizens of Cleveland County to observe this day and help us honor a man that gave his all to Cleveland County by being a man of compassion, integrity, and vision.
